

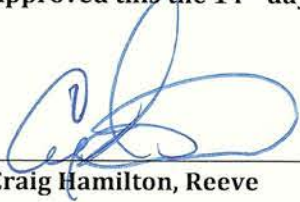

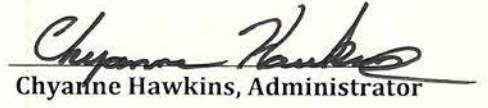

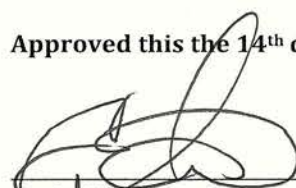

CN Rail Line – RM of Douglas No. 436	26/159 CLAIR: That the Council of the RM of Mayfield No. 406 approve partnering with the RM of Douglas No. 436 to submit a joint offer to CN Rail in the amount of \$500.00 per acre for the respective municipal portions of the former CN rail line between Denholm and Speers. <i>Carried</i>
